Form 990: What are the changes in 2008?

Passage of the Edward M. Kennedy Serve America Act

This groundbreaking legislation, the first to provide a dramatic increase in support for volunteering and nonprofits since the creation of AmeriCorps, was passed through bi-partisan support in both the House and the Senate in March. Now it awaits President Obama's signature when he returns from his current European travels. As the President himself states, "This is legislation that will usher in a new era of service in America, and I look forward to signing it into law when I return to Washington."

This bill will dramatically increase levels of volunteerism, improve and expand national service programs, including AmeriCorps, and provide for new pathways of service and

HandsOn NW NC invites nonprofits to financially support our mission to build the capacity of local

social innovation to address our nation's most pressing challenges. Beyond it's obvious impact on volunteer-oriented organizations, it also includes money that is to be focused on capacity-building as well. The Nonprofit Capacity Building Program, incorporated into the Act by the Baucus-Grassley Amendment would be administered by the Corporation for National and Community Service and authorize grants of not less than \$200,000 to larger organizations that could then be re-granted to help offset the cost of organizational development assistance to small and midsize nonprofits.

Both national and statewide partners, including The Points of Light Institute and the NC Center for Nonprofits, were influential in the creation and passage of this bill.
